The objectives within our pillars extend to our employees, temporary workers, contractors, customers, suppliers, visitors and members of the public. It also extends to our supply chain and to organisations working on our behalf, and we actively work with our suppliers to operate in a similarly responsible manner.

In order to deliver on our pillars, objectives and targets, Essentra will:

- Commit to science based targets towards net zero in our operations by 2040, and in our value chain by 2050
- Invest in renewable energy and energy efficiency
- Drive resource efficiency to reduce waste and increase reuse and recycling
- Understand and address our impacts on nature
- Increase our use of sustainable materials in our products and supporting packaging
- Engage with our local communities to provide our time and support to good causes aligned with our purpose
- Engage employees, supply chain and customers to embed sustainable practices across our operations
